Submitting your application for compensation constitutes your consent to the storage and processing of the personal data contained in this claim form, any supporting documentation and additional information provided in relation to your claim by the Shipowners' Mutual Protection and Indemnity Association (Luxembourg), 1992 Fund and their appointed representatives.

The storage and processing of such data is necessary for the purpose of reviewing and assessing your claim for compensation relating to the February 2023 MT Princess Empress oil spill. You may exercise your right to access or object to the storage and processing of personal data by submitting an application to the Princess Empress Claims Submission Office. The data obtained shall only be retained for as long as necessary and shall be destroyed after the claims processes have been terminated.

The Shipowners' Mutual Protection and Indemnity Association (Luxembourg) and the 1992 Fund reserve the right to claim back any amounts of compensation that may subsequently be proven to have been paid on the basis of false and/or fraudulent documents and evidence and to press criminal charges against any parties involved.

Evidence To Be Submitted in Support Of Claims For Property Damage

1	Extent of pollution damage to property and an explanation of how the damage occurred	
2	Description and photographs of items destroyed, damaged or needing cleaning, repair or replacement (for example boats, fishing gear, roads, clothing), including their location	
3	Cost of repair work, cleaning or replacement of items	
4	Invoice of costs incurred	
5	Age of damaged items replaced	
6	Cost of restoration after clean up, with invoices, and information on normal repair schedules	
7	Any extra income as a result of the incident
